JB: Well now that everyone is of mute uh which is good I'd like to move on to item number four on the agenda which is to accept the minutes from our IDA IDC meeting from April 21<sup>st</sup> 2021.

Do I have any questions or corrections for those minutes and if not can I have a motion?

PM: I'll make a motion to accept the meeting minutes of April 21st.

WC: I'll second.

JB: Anyone against vote 'nay'... and the motion passes the minutes are approved, the next item on the agenda number five is a resolution authorizing the agency to execute a multi-family mortgage assignment of leases and rents, security agreement and fixture filing between the Agency and WR Communities for the benefit of JPMorgan Chase Bank, in an amount not to exceed \$15,200,000... um does anyone have any question or Tom do you want to provide any background.

TD: Sorry about that yes these are all just housekeeping items uh... because we sit in title uh they need to come to us for approval to get this done and our attorneys have worked to put these items together.

JB: Thanks Rosemarie and do I have a second.

WB: Second.

JB: Alright think that was Billy thank you, all in favor vote 'Aye'.

ALL: (simultaneously) Aye.

JB: anyone against vote 'nay'... and the motion passes next item on the agenda number six is another house uh cleaning item resolution authorizing the agency to execute a mortgage and security agreement between the Agency and WR Communities um for the amount not to exceed \$1,422,308 and regulatory agreement between the Agency, the Company and State of New York Housing Trust Fund Corporation do I have a motion.

PM: I'll make the motion to accept that resolution.

JB: Alright thank you do I have a second?

WC: I'll second that.

JB: Alright all in favor vote 'Aye'.

ALL: (simultaneously) Aye.

JB: Anyone against... and the motion passes uh next item number seven on the agenda is a resolution authorizing the Agency to provide its consent to the execution by WR Communities of a promissory note in the amount of \$1,750,000 payable to the Suffolk County Treasurer authorizing the Agency to execute a mortgage between the Agency and WR Communities not to exceed \$1,750,000 and a declaration of covenants and restrictions for affordable housing between the Agency and the County of Suffolk... do I have a motion.

MD: Motion.

JB: Thank you Marcus.

CQ: I'll second.

JB: Alright all in favor vote 'Aye'

ALL: (simultaneously) 'Aye'.

JB: Anyone against... and the motion passes... next is item number eight on the agenda a resolution authorizing the Agency to execute a fee and leasehold mortgage between the Agency and WR Communities for the benefit of the Town of Babylon in an amount not to exceed \$330,000 do I have a motion.

RD: Motion to Accept.

JB: Alright thank you and how about a second.

MD: Second.

JB: Okay thank you all in favor vote 'Aye'.

ALL: (simultaneously) Aye.

JB: Alright anyone against vote 'nay'... and the motion passes... that leads us to number nine on the agenda a resolution consenting to and authorizing the execution and delivery of a Cross-Access Agreement with respect to projects of L3 Harris Technologies... uh Tom any explanation on this or this housecleaning.
