Motion was made by Paulette Moses and seconded by Marcus Duffin to accept the minutes from the July 17, 2019 IDA/IDC Board Meeting. All in favor, motion carried.

Motion was made by Paulette Moses and seconded by Rosemarie Dearing to accept the minutes from the Public Hearing held on August 19, 2019 for Railex Conveyor Corp. and Industrial Property Management, LLC. All in favor, motion carried.

Motion was made by William Bogardt and seconded by Marcus Duffin to adopt a Preliminary Inducement Resolution of the Town of Babylon Industrial Development Agency relating to the granting of preliminary approval to BH Realty Group, LLC and AvalonBay Communities Inc. in connection with the potential grant of certain financial assistance. All in favor, motion carried.

Motion was made by Justin Belkin and seconded by Thomas Gaulrapp to adopt a Preliminary Inducement Resolution of the Town of Babylon Industrial Development Agency relating to the granting of preliminary approval to WR Communities-D LLC in connection with the potential grant of certain financial assistance. Mr. Dolan and Mr. Martinez discussed this project with the Board Members. All in favor, motion carried.

All in favor, motion carried.

Motion was made by Justin Belkin and seconded by Marcus Duffin to adopt a Resolution authorizing the Chief Executive Officer to execute a Memorandum of Understanding between the Long Island IDAs and Discover Long Island related to joint marketing efforts. All in favor, motion carried.

Motion was made by Rosemarie Dearing and seconded by Paulette Moses to adopt a Resolution authorizing the Agency to execute a Subordinate Mortgage and Security Agreement between the Agency, 10 Lucon Drive LLC, the Lessee, for the benefit of Golf Gear Ltd. d/b/a Club Pro Manufacturing USA and Liftforward Lending. All in favor, motion carried.
